Objects: "The objectives of the Club shall be to educate the public in the arts and sciences, and in particular the art and science of music, by the presentation of concerts and other activities"

Organisation: The Club's concerts are held within the King's Hall complex, Station Road, Ilkley, and are widely advertised. All the organisers volunteer their services.

Financial Reserves: The Piano and Development Fund is considered a Designated Fund. Non-designated funds should not normally exceed planned expenditure.

Activities: Because of the coronavirus pandemic no live concerts were held this year. The club set up two online series of recorded concerts supplied by the previously contracted artists, which were made available to members, and in the case of the second series to other local music lovers.

Nevertheless members of the Committee have attended three full meetings by Zoom, and sub-committees have met as appropriate to discuss issues important to the success of the Club.

General Report: The Club made the decision not to hold a subscription season during 2020/21. We continued to keep in touch with members throughout the year by monthly bulletins, largely sent by e-mail. The online concert series were made available free of change although donations were requested either for the musicians involved or for Help Musicians UK.

During the year Paul Fowler retired from the Committee and in July 2021 our President, David Pyett, died. David was a mainstay of the Club, which he had served since 1947. In his 36 seasons as chairman he laid the foundations of the current success of the Club and we shall be ever in his debt.

The financial statements show the current state of the finances, which the committee considers to be sound.

The highlights of the committee's deliberations during 2021 were: overseeing the club's finances; commissioning podcasts for the club's on-line Spring series to stand-in for cancelled concerts; planning a season of normal concerts for 2021/22; agreeing the text of the concert brochure for 2021/22, including new arrangements for paying subscriptions on-line; confirming the club's publicity strategy for 2021/22; and welcoming Paul Hurst as a new member of the committee.

The committee still has openings for new members to join it. The club would especially welcome enquiries to join the committee from people with IT/Comms skills, including website design, email publicity and membership databases.

Notes to the Accounts: Year ended 31st May 2021

1. Accounting Policies

General: Ilkley Concert Club is a Registered Charity (506886). These financial statements have been prepared under the historic cost convention and in accordance with applicable accounting standards and the Statement of Recommended Practice on Accounting by Charities.

Investments: Investments are stated at market value as at the 31st May 2021.

2. Piano and Development Fund

In the year ended 31st May 2008 the Club entered into an agreement with Bradford Council for the use of a new Steinway piano for which it made a payment of £7,000. In the year ended 31st May 2010 the Club made a further payment of £2,000. Under the agreement the club will make a 50% contribution towards the maintenance costs to be incurred in future years on the piano. The fund is available for that expenditure or such other expenditure as the committee may in future decide.
